Supplies / Suppliers for The Met's Cold Storage Packaging

Item	Supplier(s)	Notes	
Rolled print boxes with tubes	Talas	Custom product, designed with Talas. Specs vary based on dimensions and weight.	
Mat board	Legion Paper	Rising Photomount (non-buffered, preferred for conservation applications, but limited color choices).	
Phototex interleaving tissue	University Products	Available in pre-cut sheets or rolls. Custom-cut sheets (e.g. for paper corners) may be possible to order. Used for interleaving prints, folded paper corners, etc.	
Heritage interleaving paper	Talas	A newer interleaving product on the market, used the same way as Phototex. Available in heavier weights, which may be better suited to certain applications, such as folded paper corners or interleaving larger materials.	
Marvelseal 360	Talas / University Products	Available in rolls of varying length.	
Foil-backed labels	University Products	Available in various sizes, suitable for inkjet or toner-based printers.	
Tape - Filmoplast P 90 Plus	Talas / University Products	Pressure-sensitive paper-backed tape, used for taping foldable corners onto mat board.	
Tape - Filmoplast SH	Talas / University Products	Pressure sensitive linen tape, used for hinging mat board folios.	
Tape - 3M Freezer Tape	Amazon	Not archival, but retains tackiness at below freezing temperatures. Used for assembling outer wrappings of polyethylene sheeting for dust/water protection in transit and in freezer storage.	
Tacking Irons / Hair Straighteners	Talas / Amazon	Tacking irons are the traditional tool, however we've had great success using hair straightening irons with programmable temperatures, such as this Remington model, which comes in 1" and 2" widths. To clean adhesive off of the plates, use acetone or rubbing alcohol, being careful to avoid getting acetone on any plastic parts.	
Jade 403 PVA adhesive	Talas	Used to assemble tube supports in custom widths.	
Polyethylene sheeting and bags	Uline	Polyethelyne comes in varying weights and bag sizes. Used for outer wrapping to protect folios and boxes in transit. Also used as protection against sprinkler systems in case of a	

		fire. We used 6 mil bags and sheets.
Double-walled corrugated board	Talas University Products	The strongest option is cross-grain double-walled corrugated board, available from University Products. At larger sizes, single direction double-walled board may be your only option. These boards are used for additional support under larger print folios which may warp when handled.
Micro Vacuum Attachment Kit	Amazon	Be sure to select a kit that is compatible with your brand of vacuum. This is the set that worked for us.

Additional supplies needed:

- Retractable utility knives and replacement blades
- Cutting mats
- Straight edges / rulers
- Tape measures
- Weights
- Scissors
- Pencils (6B is a softer lead that works well for writing on resin coated (RC) photographic prints; HB is suitable for most other needs)
- Sharpie markers (for labeling exterior Marvelseal pouches, when necessary
- Vinyl erasers
- Nitrile gloves
